On Saturday, July 16, 2022 at approximately 6:58 PM, I Corporal J. Dacosta (#1223) was conducting traffic enforcement in the 200 block of Country Club Drive. This is a two lane divided roadway, primarily residential with a posted 25 mph speed zone.

While in full Uniform and standing next to my marked Tequesta Police vehicle, I was utilizing a handheld radar unit to monitor traffic traveling North and South on Country Club Dr. I observed a gray sports utility vehicle traveling Northbound at a speed I visually estimated to be approximately 40 mph. I then activated the RADAR and received an audio Doppler tone which corresponded to my visual estimation. I then checked the target window and it showed a true speed of 44 mph. I stepped into the roadway and placed my hand out in front of me in a "Stop" gesture. The vehicle came to a complete stop approximately 10-12 feet away from me. I could see the driver through the front windshield without any obstructions. I pointed to the empty parking lot and instructed the driver to pull into it. The driver later identified by his Florida driver's license picture as Corey Lee Puckett (W/M DOB: 08/31/1994) turned the steering wheel to the left and accelerated around me. The vehicle continued Northbound on Country Club Dr.

I got into my Tequesta Police vehicle (Unit # 104) and activated my emergency equipment (lights and siren) and began to catch up to the gray SUV. As I got closer to the vehicle, it made a right turn onto Tequesta Circle. The vehicle continued to the end of the cul-de-sac were it pulled into the driveway of 252 Tequesta Circle. The driver exited the vehicle and ran on foot towards the rear of the abandoned residence. Ladvised dispatch that I had a vehicle fail to yield and the driver bailed out via my portable radio. I provided the Florida tag (97AQYC) displayed on the gray Lincoln MKC SUV. Dispatch advised the vehicle was registered to Corey Lee Puckett. A female later identified as Catherine Elise Carter (W/F DOB: 05/01/1998) by her Colorado driver's license exited the passenger side of the vehicle with her hands up. I instructed her to come back to my vehicle. I visually confirmed there were no more occupants inside the vehicle. I then returned to my vehicle and conducted a records check on Puckett. I positively identified Puckett as the driver of the vehicle by his driver's license picture.
