An anonymous subject reported a female laying on the ground crying.</p> <p>Upon my arrival on the scene, several other officers had already arrived. Officer Careccia was already in the process of interviewing the female, Cortney Charmello, who explained that she was walking southbound on the sidewalk when she was approached by her husband. Cortney explained that her husband, Dearius White, tried to pick her up in his car and in the process pushed her onto the ground resulting in a bump on her head.</p> <p>I spoke with White who explained that Cortney got heavily intoxicated at Flanigan's and started walking southbound on the sidewalk. White ran after her and tried to bring her home. According to White, Cortney slapped and punched him before falling to the ground. White denied ever touching Cortney.</p> <p>A witness who was walking down 1st St and was identified by his Texas DL as Austin Williamson advised he saw the entire altercation. Austin explained he watched White try and speak with Cortney when she suddenly dropped to the ground. Austin was adamant that White never pushed her and he did not observe any physical altercation between either of them.</p> <p>While investigating, Cortney became more and more verbally combative. As I was attempting to interview Cortney, she informed me that she was leaving. Both officer Careccia and I told Cortney she was not free to go multiple times, however, Cortney failed to listen and began to walk away. Officer Careccia and I had to physically grab Cortney and place her into cuffs all while she was actively bracing, tensing, and pulling away. Although there is insufficient evidence to establish a battery occurred between Courtney and her husband it is clear that by intentionally resisting my lawful orders and actively walking away, she did commit the offense of Resisting without</p>
