I asked Butler if she knew her right from her left and she stated she did. I had Butler extend her index fingers while making a fist. I had Butler face her paims toward me. I told Butler when I told her to, I wanted her to close his eyes and tilt her head back. I advised Butler when I instructed her to, I would tell her either left or right. I told Butler if I said right, I wanted her to touch the tip of her right finger to her nose and then return her hand back to her side.
