The following incident occurred in the city of Delray Beach, Palm Beach County, FL While working my off-duty detail at 8 E Atlantic Ave (Tin Roof) I was approached by security manager Trevor Marek who advised white male Joseph Lewis (defendant) was being verbally abusive to the bar staff and wanted him removed from the business. I spoke with Joseph and told him management wanted him to leave the business. Joseph stated he wasn't leaving because he did nothing wrong. It should be noted while talking to Joseph I noticed his eyes were red and the smell of alcohol was emanating from his breath. I advised Joseph if he didn't leave the business on his own, he would be physically removed. Joseph stated again he wasn't going anywhere. I then grabbed Joseph by his left arm and began walking him out of the business. Joseph started pushing me in my chest and stating he was not leaving. As I was walking Joseph out, I was then grabbed by Courtney Lewis (the defendant's sister) on my left arm and she stated, "leave my brother alone". I pushed Courtney back and advised her to not get involved. Courtney then threw her alcoholic beverage in my face. Both Courtney and Joseph were taken into custody. And transported back to DBPD for processing. Based on the above facts, probable cause exists to charge Courtney Lewis with FSS. 784.07(2B) Battery on a Law enforcement officer and FSS. 101.36(E)(8) Disorderly intoxication
