The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a black 2015 Lexus, 4 door, Florida 13ATAZ. The defendant stopped in a roadway travel lane without cause, then placed the vehicle into reverse. The defendant's driver side rear bumper struck the passenger side front bumper of an unmarked TPD DUI patrol vehicle (blue 2017 Dodge Charger, 4 door, city tag XF4122). The estimated damage to the unmarked police vehicle is \$200.00 in the form of deep scratches and paint transfer. The defendant then pulled forward and wasn't stopping until Officer Baden initiated a traffic stop on the defendant's vehicle. The defendant stopped inappropriately by stopping on top of a railroad crossing. Officer Baden noted signs of impairment to include the odor of an alcoholic beverage coming from the defendant's breath, slurred speech, flushed face, and bloodshot eyes. I responded to the traffic stop scene as a DUI Investigator. The defendant was advised the civil traffic crash investigation was complete and a criminal DUI investigation was now being conducted. The defendant was advised of her Miranda Rights, to which she agreed to answer questions without an attorney being present. The defendant had a strong and distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed and her speech was slurred. The defendant was unsteady exiting her vehicle, her gait was unsteady, and she swayed while standing. The defendant stated that she drank two glasses of wine tonight. The defendant made numerous repetitive statements, indicating an inability to remember what she had already said. The defendant ultimately refused to submit to Field Sobriety Exercises after being advised of the purposes of the FSE's and possible consequences of refusing to participate in the FSE's. The defendant exhibited signs of impairment, and based on a totality of the circumstances she was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purposes of determining its alcohol content after being advised of the Implied Consent Warnings. The defendant has a documented prior refusal to submit to a lawful test of her breath, urine, blood, as verified via DHSMV and DAVID. The defendant was positively identified by her FL DL.
