The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 03/31/2022 19:37

On , at (Specifically include facts constituting cause for arrest.)

On 03/31/22, at approximately 1937 hours, I, Sergeant R. Ermeri was conducting Stationary Traffic Enforcement at the intersection of Adams Road and Old Ocean Blvd, in Ocean Ridge, when I observed a Blue in color, Low Speed Vehicle (LSV) fail to make a complete stop at the stop sign on Old Ocean Blvd at the intersection of Adams Road.

My Patrol Car was positioned to the far south east side of Adams Road and I had a clear view of all three Stop Signs at the intersection.

The blue in color LSV was traveling north bound on Old Ocean Blvd and was being operated by Cynthia Philips Martel, (W/F 03-10-70) who is personally known to me.

I turned left on Old Ocean Blvd and began to follow the LSV.

I observed that Cynthia Philips Martel stopped the vehicle in the area of the 5900 Block of Old Ocean Blvd, on the far east side of the road and began a conversation with a white male who was walking two dogs.

It was apparent to me that Cynthia Philips Martel saw me (she looked to her left as she passed through the intersection), in my full class B duty uniform conducting Stationary Traffic Enforcement in a Fully Marked Patrol Car and was now ignoring the fact that I am sitting stationary right behind her.

I lit my rear emergency lights and conducted a traffic stop on this vehicle which had Florida tag #PDZV25 attached and made contact with Cynthia Philips Martel who was not belted and not in possession of her drivers license.

Cynthia Philips Martel was advised the reason for the stop and I returned to my patrol car to issue her a Warning.

A short time later her husband Victor Martel (W/M 10-22-58) responded to the scene of my traffic stop and parked his vehicle just to the north of his wifes' LSV on the far west side of the road.

Victor Martel, who's Florida drivers license is suspended, entered the immediate area of my scene and began to cause a disturbance by demanding my name and badge (ID) number.

Cynthia Philips Martel approached the driver side of my patrol car to present her drivers license to me. I informed Cynthia Philips Martel that I did not need it and I asked her to reposition herself in front of my patrol car. Cynthia Philips Martel, who refused to move, had to be directed a second time to reposition herself in front of my patrol car (refused) and then directed to go back by her vehicle to which she finally complied.

I made contact with Victor Martel and informed him that his license is suspended and I indicated that he is not free to go.

While I was returning to my patrol car, Cynthia Philips Martel did willfully flee the area traveling north bound, on Old Ocean Blvd, inside her LSV and refused to stop despite me calling out to her by name (Cindy) and despite my order (Cindy, don't leave) and after being informed (You are not free to go).

Cynthia Philips Martel eventually did return to scene, However, it was not in accordance with my Lawful Orders, she returned to the scene following a phone call from her husband demanding that she return.

At the conclusion of this traffic stop, I determined the following:

Cynthia Philips Martel was lawfully stopped for Failure To Stop At A Stop Sign contrary to Florida Statute 316.123(2)(a).

Cynthia Philips Martel did operate a vehicle, having knowledge that he/she had been ordered to stop such vehicle by a duly authorized law enforcement officer, and did willfully refuse or fail to stop the vehicle in compliance with such order, or having stopped in knowing compliance with such order, did willfully flee in an attempt to elude the officer, contrary to Florida Statute 316.1935(1).

Cynthia Philips Martel did resist, obstruct or oppose Sergeant R. Ermeri, a law enforcement officer of the Ocean Ridge Police Department, in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02.

Because both Cynthia Philips Martel and her husband Victor were not cooperating with me and because I believed that they would both Aggressively Resist my efforts, I decided to not place Cynthia Philips Martel under arrest at this time. In an effort to de-escalate this situation, Cynthia Philips Martel was issued a Warning for the Stop Sign Violation and Victor Martel was issued a Florida Uniform Traffic Citation For DWLS Without Knowledge.

Because Cynthia Philips Martel, having stopped in knowing compliance with my traffic stop, did willfully flee the stop in an attempt to elude me and because she resisted and opposed my order to not leave, I believe that Probable Cause does exist
