The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the above listed date and time, I responded to 13646 Park Lake Dr, in reference to a domestic violence in progress. Upon arrival, deputies could hear screaming coming from inside the residence, indicative of a physical altercation. Deputies knocked and announced their presence, and the defendant continuously refused to open the door and advised for deputies to come back with a warrant. A male was observed in the kitchen inspecting his right forearm and used his left hand to pat his forearm. Deputies could see other adults inside the residence cleaning up broken glass in the kitchen. The defendant was heard continuously yelling at the other occupants that they "are not on the lease and need to leave." With previous history of domestic violence at this residence and the totality of the circumstances this created exigent circumstances to enter the apartment to conduct a lawful investigation. While taking the defendant into custody, she actively resisted by pulling away from deputies. As she was escorted outside, the defendant used her left foot to kick Deputy Wheaton in the abdomen. Deputy Wheaton did not sustain any physical injuries during the incident. The defendant was identified via DHSMV photo.
