Before me this date personally appeared AUGUSTIN, WISLY (3782) who being first duly sworn deposes and says that on 9 day of January (year) 2022 at 1100 SUNSET STRIP, SUNRISE, FL 33313 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

vehicle. While talking to Dana, a strong odor of alcohol was emitting from her person and was slurring her words Dana had possession of her keys and stated her vehicle was parked directly in front of the store Contact was made with numerous individuals at the front of the store who advised they had been outside for 30 mins plus and did not observe Dana park a vehicle Dana's vehicle was located by another officer just west of the location she advised she parked Dana was advised not to drive her vehicle and walk home Dana was later observed driving her 2011 Ford Escape bearing Florida tag HEGC17, just minutes after being told not to drive

The defendant was advised of my suspicion of her being possibly impaired and was read her Miranda right and was asked to take a Standardized Field Sobriety Exercise, to which she advised she would participate During the Horizontal Gaze Nystagmus, she displayed the inability to track the stimulus evenly and could not follow the stimulus with her eyes without moving her head The defendant displayed Distinct and sustained Nystagmus at maximum deviation, with her eyes continually jerking left to right The defendant displayed minor signs of vertical Nystagmus as well During the Walk and Turn, prior to the defendant conducting the test, she was read the instructions The defendant advised she understood and stated she understood the instructions after being demonstrated by myself as well The defendant was unable to stand still during the demonstration and could not keep balance while listening to instructions During the defendant's test, she did not walk Heel to Toe, walking more than nine steps, stepped off the line, used her arms for balance, and turned improperly

Based on the defendant's inability to stand and take proper instructions, no other Standardized Field Sobriety Exercise were conducted. She was placed under arrest based
