The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 07/16/2022 at 0107 hours, the defendant was observed as the sole occupant and driver of his 2018 Nissan (FL tag no. KSQM07) by Ofc. Darling, driving North on 16th St / 7th Ave which is a one-way stretch of road in Ybor City, Hillsborough County, FL.

Upon coming into contact with the defendant, Ofc. Darling observed several signs of impairment as he spoke with the defendant who remained seated in his vehicle. The affiant was requested to assist with conducting a series of Standard Field Sobriety Exercises (SFSEs) with the defendant and during the SFSEs the defendant displayed several signs of impairment. The defendant voluntarily consented to providing a breath sample which resulted in a .194 BAC.
