Before me this date personally appeared ROCHA, DANIEL (17679) who being first duly sworn deposes and says that on 6 day of September, (year) 2017 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

enough money to catch a flight home. She gave him an ultimatum to pick his wife or the strangers that he just met which is when he began to tell her she needs to leave.

[REDACTED] did not want to leave which is when Daniel began to push her out of the house while repeating that she needed to leave.

Once outside [REDACTED] began to yell for help attempting to get a neighbors attention, while on her cellphone with a friend. Daniel then approached her an attempted to get her cellphone from her hand, pushing her down to the ground in the middle of the road. He then entered the house and began to pack up her belongings.

An anonymous neighbor heard [REDACTED] yelling for help and began to approach her after he saw Daniel push her to the ground. This same neighbor flagged me down as I was approaching the scene and advised that he witnessed her being pushed down to the ground in the middle of the road.

[REDACTED] sustained minor swelling and small scrapes with minor bleeding to her left knee as a result of being pushed to the ground.

Body Worn Camera was activated.
