Before me this date personally appeared MUNOZ, DANIEL (19092) who being first duly sworn deposes and says that on 3 day of June, (year) 2022 at 1841 WAY POINTE PL, DANIA BEACH, FL 33004 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

he told Pope that he wanted to stop at the Bowlero to hang out with a few of his friends who were there [REDACTED] stated that Pope was not very happy about going to the Bowlero but went anyways [REDACTED] stated after being at the Bowlero for a while, Pope began stating she wanted to leave now, however, he wanted to stay for one game at least [REDACTED] stated this made Pope angry and aggressive and while standing in front of him, she began to slap him with an open hand, approximately three times, on the right side of his face [REDACTED] stated Pope did this in front of all his friends

It should be noted that [REDACTED] and Pope are currently dating and have been in an intimate continuous relationship for the past 8 months

Due to Pope intentionally striking [REDACTED] against his will multiple times on his face, Pope is being charged with F S S 784 03-1A1 (HGD) TOUCH OR STRIKE/BATTERY/DATING VIOL

Pope was transported to BSO Main Jail without further incident
