Upon arrival, I made contact with Deputy Zahorovsky #19325. He advised that he and other Deputies were about 100 yards west of University Drive and Hillsboro Blvd on a traffic stop. After they cleared the traffic stop, they observed a vehicle traveling eastbound with one headlight and they could hear a scraping noise coming from the vehicle. As the vehicle got closer, it ran the stop sign and collided into a guardrail. Deputies approached the vehicle and observed a white female driver (sole occupant). The driver was identified to be Marina Danilina. Deputies asked Danilina if she needed Fire Rescue and she refused. As Zahorovsky spoke with Danilina he observed the following signs of impairment; slurred speech, couldn't maintain a conversation, glossy eyes and an 'odor of an alcoholic beverage emanating from her person. \*\*It should be noted that at about the 10800 block of Hillsboro Blvd there was a downed traffic sign in the eastbound lanes. There was debris (white pieces) and a piece of a vehicle's under carriage with part number (51447-06020) in the roadway. That part number came back to a 2018-2019 Toyota Camry under carriage engine over. Danilina's vehicle is a 2019 white Toyota Camry. I made contact with Danilina and advised that the crash investigation was complete and I would be conducting a separate DUI investigation. I asked Danilina if she would be willing to participate in field sobriety exercises, she stated yes. I then asked the following questions and received the following answers: Are you Diabetic? She was placed in handcuffs and asked if she would take the breath test. She stated that she was a single mother and for me not to do this. I attempted to bring her attention back to whether or not she wanted to submit to the breath test, but she kept asking me not to arrest her. I read Danilina the Florida Implied Consent and she agreed to take the test. During the 20 minute observation, Danilina kept asking what was her options to get out of this, how much money did she have to pay and if I could just take her home. I advised Danilina that my arrest decision has been made and she would be getting transported to BSO Main Jail, she advised that jail wasn't an option. Danilina continued to ask how much she had to pay to get out of this. I advised Danilina that attempting to bribe a public official was a crime, she stated "how much do I have to pay you to not go to jaıl." After the 20 minute observation, as she was providing her first breath sample, I noticed that she wasn't holding her lips tight on the mouth piece. I explained and demonstrated how to blow into the mouth piece properly and she continued to do it incorrectly. As I attempted to take the mouth piece out of her mouth, I wasn't able to because she was biting on it. I told Danilina not to bit on the mouth piece and she stated that she didn't have to do this.
