

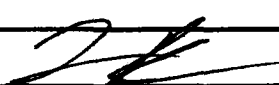

P R O B A B L E	The following is a summary of what occurred for further information please view my body worn camera. This incident occurred at 180 NE 4th Ave, City of Delray Beach, Palm Beach County, Florida.								
	On Thursday, August 4, 2022, at approximately 2203 hours, I responded to 180 Ne 4th Ave in reference to a Disorderly intoxicated Report. Upon arrival, I met with Darryl Kroeze at the north side of the building. Kroeze was sitting on the ground and appeared to be intoxicated. It should be noted that Kroeze was intoxicated and caused a disturbance at Johnny Browns located at 301 E Atlantic Ave and was advised by officers to leave the business (Event#:20220087649). Kroeze advised that he was sitting down at his apartment and was not doing anything wrong. I informed Kroeze that dispatch received a call that he appeared to be intoxicated and needed assistance. When I asked Kroeze if he had an ID to identify himself, he advised that he did not need to provide me anything. Kroeze then became verbally abuse by stating "Fuck you, pussy, "motherfucker" and "You piece of shit." Kroeze then stated that he was attempting to meet his friend at his apartment but was unable to provide a unit number. Delray Beach Fire Department (DBFD) responded to the scene to medically evaluate Kroeze, but he refused medical attention and became verbally abusive towards DBFD by stating "Fuck you." Kroeze then requested to speak with a supervisor. Sergeant Saraceni responded to the scene and spoke with Kroeze. Kroeze informed Sergeant Saraceni that he was drunk. While Sergeant Saraceni was attempting to explain Kroeze the nature of the call, he began to step towards our direction in an aggressive manner and continued stating verbally abusive language. In fear that Kroeze was going to become physically violent, he was placed in handcuffs.
