The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, near the intersection of Prairie Valley Ln. and Dorado Shores Ave., the affiant responded to a Traffic Crash call for service, which involved an alleged impaired motorist (HCSO case #22-617854 / DHSMV #24641455). The defendant was operating a blue Honda Pilot bearing FL tag Y512XS (VIN #5FN9YF3H54EB013541) and involved in a single vehicle traffic crash when he veered off the roadway to the right and caused approximately \$500.00 in property damage. Upon Deputy Y. Hibbard's (ABN #252159) arrival at the scene, she observed the defendant in the driver seat of the listed vehicle with the listed vehicle's key in his front pants pocket. During Deputy Y. Hibbard's contact with the defendant, she detected indicators of impairment. The affiant responded to the scene and also detected several indicators of impairment, which included the odor of an alcoholic beverage emitting from his breath as he spoke, slurred speech and bloodshot and glassy eyes. The affiant requested the defendant perform the Standardized Field Sobriety Exercises (SFSE's), which the defendant agreed to perform. During the SFSE's, the defendant displayed signs of impairment and was subsequently arrested for DUI. The defendant was transported to Central Breath Testing (CBT) where he agreed to provide two lawful breath samples to determine his breath alcohol content (BrAC). Breath Technician J. Piercey (ABN #4553) provided the affiant with the defendant's BrAC results, which were as follows: First BrAC sample (.148); Second BrAC sample (.141). The affiant issued the defendant a DUI citation (AGQIC0E), which reflects the DUI charge. The defendant was identified via his valid FL driver license.
