On Friday, November 5, 2021 at approximately 0309 hours, Deputy Garvey #18018 observed Defendant Dawn Andrie driving her 2017 black Nissan Rogue (FL tag: WBN664) eastbound in the 900 block of W Hillsboro Blvd., Deerfield Beach, Broward County, FL, drifting from lane to lane, keeping him at bay, and unable to pass safely. **Probable Cause Affidavit**

Before me this date personally appeared POPICK, SCOTT (11307) who being first duly sworn deposes and says that on 5 day of November, (year) 2021 at 900 W HILLSBORO BLVD BLK, DEERFIELD BEACH, FL 33441 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

continuing southbound on S Dixie Hwy. Deputy Garvey initiated a traffic stop in the 300 block of S Dixie Hwy, where the Rogue pulled into the center of the roadway, over the solid double yellow lines, and into the northbound left turn lanes. Deputy Garvey requested the driver lower her window, but met some resistance. She eventually lowered her window. The driver identified herself with her FLDL. During contact, Andrie stated she was on the way home from a party, where she consumed several drinks. She stated she lived around the corner and just wanted to go home. During this conversation, Deputy Garvey detected an odor of alcoholic beverages emanating from her breath. She also slurred her speech, and was unable to understand simple lawful instructions. She also refused to provide her car keys upon request. I was contacted at 0316 hours to respond and conduct a DUI investigation.

I arrived on scene at 0340 hours and was informed of the aforementioned by Deputy Garvey. I contacted Andrie, who was still seated in her driver's seat. Andrie was on the phone, stating she was talking with her mother. I introduced myself and explained I was on scene to conduct a DUI investigation. I requested she put the phone down so her attention could be with me, but she refused. I requested she walk to the front of my patrol vehicle, which was equipped with additional lighting and a dash camera, but she refused to exit her vehicle. She stated she was uncomfortable getting out of the car and that she just wanted to go home. She kept stating she was not going to complete the roadside sobriety exercises. I informed her that I could detect the odor of alcoholic beverages emanating from her breath and that her eyes were glassy. I advised her that by refusing to complete the exercises, she would not be able to dispel my concerns that she was not impaired, and that refusing to do the exercises can be used against her in court. I informed her that I would have to make a decision regarding arrest based on the

Before me this date personally appeared POPICK, SCOTT (11307) who being first duly sworn deposes and says that on 5 day of November, (year) 2021 at 900 W HILLSBORO BLVD BLK, DEERFIELD BEACH, FL 33441 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

totality of the information I had obtained up to this point. She wanted to talk to her mother for advice. At this time, a train went by, and I waited for it to pass, as it was too loud to converse with her. She then took a drink from metal tumbler in the center cup holder, and I instructed her not to drink anything else. She responded, "It's just water." As I told her since I could not confirm the liquid in the container, I did not want her to drink any further. She complied, but still told me several more times, "It's just water." I asked her again to perform roadside sobriety exercises with me, but she refused to comply. I informed her I developed enough Probable Cause to place her under arrest for DUI, and the only way to change any opinion on this matter about her sobriety would be to perform the exercise. She still refused to cooperate.

I placed Andrie under arrest at 0359 hours and requested a breath test, to which she replied she would not provide. At 0404 hours, I read her the Florida Implied Consent Law, to which she stated she didn't understand. I read the paperwork several more times, but she stated she still would not provide a breath test. At 0405 hours, I read Andrie her Miranda Warnings, per BSO issued card, and she stated she understood, but would not answer questions. Andrie was transported to the BSO Deerfield Beach Office for paperwork completion, and then to the BSO Main Jail for further detention. BSO and Patrol Vehicle Dash Cam
