Deputy Garvey initiated a traffic stop in the 300 block of S Dixie Hwy, where the Rogue pulled into the center of the roadway, over the solid double yellow lines, and into the northbound left turn lanes. Deputy Garvey requested the driver lower her window, but met some resistance. She eventually lowered her window. The driver identified herself with her FLDL. During contact, Andrie stated she was on the way home from a party, where she consumed several drinks. She stated she lived around the corner and just wanted to go home. During this conversation, Deputy Garvey detected an odor of alcoholic beverages emanating from her breath. She also slurred her speech, and was unable to understand simple lawful instructions. refused to provide her car keys upon request. I was contacted at 0316 hours to respond and conduct a DUI investigation. I arrived on scene at 0340 hours and was informed of the aforementioned by Deputy Garvey. I contacted Andrie, who was still seated in her driver's seat. Andrie was on the phone, stating she was talking with her mother. I introduced myself and explained I was on scene to conduct a DUI investigation. I requested she put the phone down so her attention could be with me, but she refused. I requested she walk to the front of my patrol vehicle, which was equipped with additional lighting and a dash camera, but she refused to exit her vehicle. She stated she was uncomfortable getting out of the car and that she just wanted to go home. She kept stating she was not going to complete the roadside sobriety exercises. I informed her that I could detect the odor of alcoholic beverages emanating from her breath and that her eyes were glassy. I advised her that by refusing to complete the exercises, she would not be able to dispel my concerns that she was not impaired, and that refusing to do the exercises can be used against her in court.
