On the listed date, time, and location, the defendant and the victim were engaged in a verbal altercation. The verbal altercation escalated when the defendant scratched the victim numerous times in the face and chest area. The victim and defendant [REDACTED] Upon arrival, I heard the victim screaming "stop" numerous times as I approached the residence. I made contact with the defendant at the front door of the residence and observed slight redness to her neck area. I also observed a small scratch on the defendant's upper left foot. I made contact with the victim within the living room area of the residence. I observed the residence to be in complete disarray as multiple objects were broken on the ground with multiple pieces of furniture flipped over. The victim relayed, "she put hands on me". The victim removed [REDACTED] sweat shirt and I observed multiple actively bleeding scratch marks on the victim's chest area and shoulders. I further observed a scratch on the victim's nose. The defendant did not wish to provide a statement post Miranda. The defendant identified herself verbally. The victim positively identified the defendant as the person who committed the offense. No firearms were utilized during this incident.
