Probable Cause Affidavit

Before me this date personally appeared WALKER, ELONZO (4941) who being first duly sworn deposes and says that on 12 day of February, (year) 2022 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33314 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

simple battery when she intentionally struck victim, Ronald Simon (B/M, DOB 02-16-71) against his will. Simon (a Hard Rock Security Officer working at the Hollywood Tower Key check) stated he asked to see Daffron's hotel key when she attempted to enter the elevators that lead to the hotel rooms. Simon advised Daffron then became upset and hit him in the face. A review of Hard Rock Video surveillance showed Daffron slap Simon's right hand with her right hand and she also grabbed his security radio shoulder mic with her right hand. Daffron then walked away.

Daffron was subsequently placed under arrest and charged with simple battery. Daffron was then transported to BSO Main Jail for further processing.
