On the 16 day of July, 2022 at 22:15 (Specifically include facts constituting cause for arrest.) On 07/16/2022 at approximately 2215 hours, this Officer was acting as part of the Jupiter Police Department mutual aid Driving Under the Influence Saturation patrol and conducting speed enforcement in the area of the 800-block of N US Highway 1, Jupiter, FL, when a vehicle was observed traveling at an increased rate of speed north bound in the outside through lane. Body worn camera and in car video were used in the investigation. This Officer initially visually estimated the vehicle, a black Ford pick-up (37DFC/FL) to be approximately 60 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), rear antenna (KR027120) this Officer received a steady tone and reading of 63 MPH. The RADAR calibration was last checked on 05/09/2022 and was due on 11/09/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer followed the vehicle over the bridge and initiated a traffic stop on same, in the first safe location, on US Highway 1 just south of Beach Rd, Jupiter, FL. This Officer made contact with the driver and sole occupant, identified via Florida Driver License photo, Diandra Giovengo (OF) while she was still in actual physical control of same. This Officer observed Giovengo to have a flushed face, slow slurred speech, red watery eyes, and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. This odor increased as Giovengo spoke and as the investigation continued. Giovengo said she was coming from a birthday dinner and that she had recently lost her dog. Giovengo said she was on her way home and had dinner with her parents at "Aqua Grill". When asked if she had anything to drink, Giovengo said she had a "like a beer or two, but not to be intoxicated". It should be noted, each time this Officer asked Giovengo a question, she would lose focus on what

she was doing and appeared to have difficulty dividing her attention.

Based on this Officer's observations, Giovengo was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which she complied. Giovengo said she did not have any medical conditions which would affect the exercises performed.

The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight with an illuminated red tip. Giovengo had a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation as well as the onset of Nystagmus in both eyes prior to 45 degrees. Giovengo had to be told to keep her head still during the exercise. While the exercise was being conducted, Giovengo stopped, brought her hands to her face and began sobbing, and said "I just lost my dog" "I promise I'm not drunk".

The second exercise conducted, was the Walk and Turn. The line used was a traffic sensor in the pavement, which was straight, level and clear of debris. During the instructions, Giovengo started the exercise prior to being told to do so. While completing the first set of steps, Giovengo was holding onto the sides of her dress with her hands. Once she completed the nine steps, she stepped her lead foot back then pivoted on both feet rather than taking a series of small steps. During the return this Officer instructed Giovengo to let go of her dress. Once she did, she raised both arms well over six inches from her sides. During her six and eighth steps, she missed heel-to-toe by more than a half an inch.

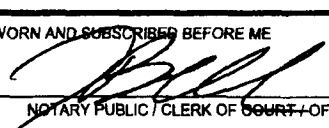
The third exercise conducted, was the One-Leg Stand. During the exercise, Giovengo raised her right foot. Giovengo swayed during the exercise and kept both arms raised more than six inches from her sides.

The fourth exercise conducted, was the Finger to Nose. During the exercise, the following observations were made: The first command of Left, Giovengo touched the tip of her nose with the pad of her finger and had to be told to lower her hand. The first command of Right, Giovengo tilted her head forward and again used the pad of her finger to touch the tip of her nose and had to be told to lower her hand. The second command of Left, she again used the pad of her finger to touch her nose and also had to be told to lower her hand. The second command of Right Giovengo touched her nose with the side of her finger and had to be told to lower her hand. The third command of Right, she again touched the side of her finger to her nose and had to be told to lower her hand. The final command of Left, she touched the pad of her finger to the tip of her nose and had to be told to lower her hand.

The fifth and final exercise conducted, was the Modified Rhomberg Balance. Giovengo estimated the passage of 30 seconds in approximately 35 seconds.

P R O B A B L E C A U S E S T A T E M E N T	Based on this Officer's observations and the totality of the circumstances, Giovengo was placed under arrest at 2233 hours. After arrest, Giovengo's attitude began to deteriorate. Giovengo became argumentative, loud and accusatory toward this Officer. During a tow inventory of the vehicle, this Officer located contraband. Inside Giovengo's purse, this Officer located a black case in a hidden side pocket, which contained a "vape pen". Loaded in the pen was a clear cartridge with a thick brown liquid contained within. This liquid later field tested positive as Cannabis. Giovengo had previous uttered being a medical Marijuana patient, while this Officer was able to confirm her status as such, the registry made no mention of Tetrahydrocannabinol oil. The item was seized by this Officer. On the roadside, this Officer requested Giovengo to provide a breath sample, to determine its alcohol content, to which she refused. This Officer read updated Florida Implied Consent, via Florida DOT Cards to Giovengo, twice, to which she argued and provided unsure answers, then said her lawyer would tell her to say no. This Officer asked Giovengo what her answer was not her lawyer's, to which she refused at 2252 hours. It should be noted, Giovengo had a prior refusal to submit to a lawful sobriety test dated: 07/25/2011 and a prior DUI conviction dated: 01/24/2012. Based on the results of the investigation, this Officer has probable cause to prove Diandra Giovengo operated a motor vehicle, in the state of Florida, while under the influence to the extent her normal faculties were impaired, in violation of FSS 316.193(1)(A). Giovengo also refused a lawful sobriety test with a prior refusal, in violation of FSS 316.1939(1). Lastly, Giovengo was in possession of a banned substance, in violation of FSS 893.13(6)(A).
