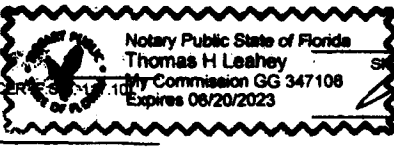
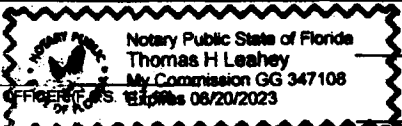

Officer Kenny who was driving north turned his vehicle around and followed the vehicle. Officer Kenny conducted a license plate check on the vehicle. The result of the license plate check revealed that the registered owner of the vehicle, Dianne Hinterberger (wf 10/30/1963) had a suspended license. Officer Kenny conducted a traffic stop of the vehicle at 800 Ocean Drive, Juno Beach, Florida. As Officer Kenny approached the vehicle and made contact with the driver. The driver was identified as Dianne Hinterberger (10/30/1963) from her Florida drivers license. I arrived on the scene as a back up officer for Officer Kennys traffic stop. As I approached the passenger side of the vehicle and made contact with Hinterberger a very strong odor of alcohol came out of the vehicles open window. Hinterberger had the AC in the vehicle on at the max setting which spread the odor of alcohol even more. After communicating with Officer Kenny about their conversation it was made evident that further investigation of the driver was necessary. Officer Kenny stated that the driver made comments about going out for drinks at a restaurant in Jupiter. Hinterberger stated she had two glasses of wine. I made contact with the driver and asked Hinterberger to step out of the vehicle. Hinterberger was unsteady on her feet while standing outside of the vehicle. I stated that her license was suspended due to an FR-Suspension from 06/02/2022. Hinterberger was unsure why her license was suspended. While describing the circumstances surrounding why her license might be suspended her speech was slurred and her thoughts were unfocused. The odor of alcohol was coming off of her breath. Hinterbergers eyes appeared glassy.

I asked Hinterberger if she would be willing to conduct a few road side tasks to determine if she would be okay to drive. Hinterberger stated she would do the tests. The first test that I conducted was the horizontal gaze nystagmus. I read the directions to Hinterberger. Hinterberger showed lack of smooth pursuit in both the left and right eye. She continued to move her head instead of just her eyes after being told to only move her eyes. She showed distinct and sustained nystagmus at maximum deviation and showed an onset of nystagmus prior to 45 degrees. She showed vertical nystagmus as well. The next test conducted was the walk and turn. After reading the directions out loud off of my SFST book Hinterberger began the test before being told to do so. Hinterberger could not keep her balance while listening to the instructions. Hinterberger failed to touch heel to toe on almost every step and took 12 steps going one way, performed an improper turn and performed 11 steps coming back. The final test conducted was the one leg stand. After reading the directions out loud Hinterberger began. Hinterberger stated after a few seconds of doing the test that she was not able to do it. I find probable cause to arrest Dianne Hinterberger for violating Florida Statute 316.193(4).

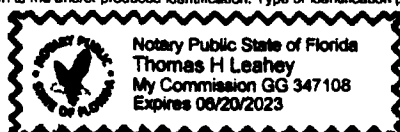

On 06/23/2022 at approximately 2131 hours Officer Kenny was conducting traffic enforcement at 1300 Ocean Drive, Juno Beach, Florida when a Silver SUV appeared to be driving over the speed limit going south. Officer Kenny who was driving north turned his vehicle around and followed the vehicle. Officer Kenny conducted a license plate check on the vehicle bearing Florida tag (22AKNK). The result of the license plate check revealed that the registered owner of the vehicle, Dianne Hinterberger (wf 10/30/1963) had a suspended license.

Officer Kenny conducted a traffic stop on the vehicle at 800 Ocean Drive, Juno Beach, Florida. As Officer Kenny approached the vehicle and made contact with the driver. The driver was identified as Dianne Hinterberger (10/30/1963) from her Florida drivers license.

I arrived on the scene as a back up officer for Officer Kenny's traffic stop. As I approached the passenger side of the vehicle and made contact with Hinterberger, a very strong odor of alcohol came out of the vehicles open window. Hinterberger had the AC in the vehicle on at the max setting which spread the odor of alcohol even more. After communicating with Officer Kenny about their conversation it was made evident that a further investigation of the driver was necessary. Officer Kenny stated that the driver made comments about going out for drinks at a restaurant called EVO in Tequesta. Hinterberger stated she had two glasses of wine.

I made contact with the driver and asked Hinterberger to step out of the vehicle. Hinterberger was unsteady on her feet while standing outside of the vehicle. I stated that her license was suspended due to an FR-Suspension from 06/02/2022. Hinterberger was unsure why her license was suspended. While describing the circumstances surrounding why her license might be suspended, her speech was slurred and her thoughts were unfocused. The odor of alcohol was coming off of her breath. Hinterbergers eyes appeared glassy.

I asked Hinterberger if she would be willing to conduct a few road side tasks to determine if she would be okay to drive. Hinterberger stated she would do the tests.

The first test that I conducted was the horizontal gaze nystagmus. I read the directions to Hinterberger. Hinterberger showed lack of smooth pursuit in both the left and right eye. She continued to move her head instead of just her eyes after being told to only move her eyes. She showed distinct and sustained nystagmus at maximum deviation and showed an onset of nystagmus prior to 45 degrees. She showed vertical nystagmus as well.

The next test conducted was the walk and turn. After reading the directions out loud off of my SFST book, Hinterberger began the test before being told to do so. Hinterberger could not keep her balance while listening to the instructions. Hinterberger failed to touch heel to toe on almost every step and took 12 steps going one way, performed an improper turn and performed 11 steps coming back.

The final test conducted was the one leg stand. After reading the directions out loud, Hinterberger began. Hinterberger stated after a few seconds of doing the test that she was not able to do it.

I find probable cause to arrest Dianne Hinterberger for violating Florida Statute 316.193(4).

Hinterberger was seached by Officer Picard (356) of the Jupiter Police Department. Hinterberger vehicle was subsequently towed by Kauffs Towing.

Hinterberger was transported to the Palm Beach County Jail BAT center where a twenty minute observation was
