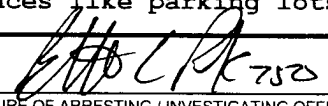

On 10/10/2019, I was assigned the following indecent exposure investigation, in reference to Boca Raton Police Department case #2019-010571. The following is a summary of the case: On 08/06/2019, at approximately 1755 hours, the victim _____ reported that she observed an unknown white male masturbating in his vehicle, in the parking lot of _____. _____ parked her vehicle in the parking lot on the south side of _____ at approximately 1640 hours. While sitting in her vehicle, texting a friend, she observed a white pick-up truck pull into the south side of the parking lot and park along two parking spots, across from her view. The driver of the white pickup truck was a white male, in his late 20s to early 30s. _____ could not provide any further description of the male. The white male then opened his driver door, looked in _____ direction, and began masturbating while inside of the truck. _____ explained that she could see the male's exposed penis when he was masturbating, because he opened the driver door of his truck and faced towards her while masturbating. After several minutes, _____ exited her vehicle to walk into her job at _____. _____ the suspect then left the area in his vehicle. The suspect never said anything to _____, and she did not confront him. _____ stated that the pickup truck appeared to be a Ford F250 or F350 (unknown tag). Ofc. Deen reported that she viewed the video surveillance of the incident with _____ Loss Prevention Officer _____. The video surveillance showed when the suspect vehicle parked near the victim's vehicle _____ and when the suspect opened the driver door of the pick-up truck; however, due to the quality and angle of the video surveillance, a description of the driver/suspect was unable to be determined. The parking lot was searched and neither the vehicle nor the suspect were able to be located. _____ stated that she has never seen the suspect before and she did not believe she would be able to identify him in a photo line-up. callers for this incident. A crime information bulletin was created containing a still photograph of the vehicle captured on the video surveillance. It should be noted that there was a similar incident that occurred on 10/02/2019, at approximately 1307 hours, near the Starbucks parking lot (located at 1830 N. Federal Hwy. in Boca Raton). The victim in this case also described the suspect as a white male masturbating inside of a white pick-up truck (BRPD case #2019-013330). A check of LPR cameras in the area indicated that the same 2017 white Ford pickup truck (FL tag 980MLI) was captured in the area, during the timeframe that both incidents occurred. On 08/06/2019 at 1645 hours the vehicle was captured in the area of W. Glades Rd. and NW Renaissance Way. This intersection is located 0.9 miles (according to Google maps) from where [REDACTED] saw the suspect vehicle, during the same time frame. On 10/02/2019, at 1204 hours the vehicle was captured in the area of N. Federal Hwy. and Palmetto Park Rd. This intersection is located 1.3 miles (according to Google maps) from where the second incident occurred. The vehicle is registered to white male, Dick Algea (DOB: 03/29/1989), at the address of 1971 NE 31st St. in Lighthouse Point. A check of Algea's criminal history indicated that he has previously been arrested for and been listed as a suspect in multiple indecent exposure cases. On 10/11/2019, Det. Kingman and I responded to Algea's residence, located at 1971 NE 31st St., in Lighthouse Point and made contact with him and his wife [REDACTED]. It should be noted that the suspect vehicle (FL tag 980MLI) was parked in the driveway of the residence. The interview was audio recorded and submitted into evidence. The following is a summary of the interview: Algea agreed to speak with us in front of his wife. I informed Algea that we were investigating several incidents in Boca Raton where his vehicle and vehicle tag had been seen in the corresponding area. I then asked Algea if he knew what incidents I was referring to and he responded, "Yea I know exactly what it is". When I asked him to explain he then said, "I was masturbating in a parking lot, I didn't know if the girl was next to me". He further explained that this occurred near an office and that someone came out and attempted to record him. Algea admitted that this incident occurred in a parking lot with trees, near a Starbucks. It should be noted that this description of events matches the incident that was reported in BRPD case #2019-013330. When I asked Algea if he could remember another incident where he was masturbating in public, near a [REDACTED], Algea stated that he could not remember this specific incident. I showed Algea the still photograph of the suspect vehicle from the [REDACTED] video surveillance and he positively identified the suspect vehicle as his Ford pick-up truck (FL tag 980MLI). Algea confirmed that he is the only one who drives this vehicle. Algea explained that he has a problem and often masturbates in public places, in his vehicle, while on his lunch break. He works in construction and often works in Boca Raton. See the taped statement for further information. Algea admitted that he often masturbates in public places like parking lots and he

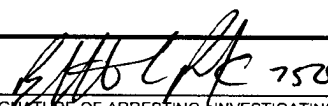

Based on the above information, Dick Algea did expose or exhibit his/her sexual organs in a public place, or on the private premises of another or so near thereto as to be seen from such private premises, in a vulgar or indecent manner, or so to expose or exhibit his/her person in such place, or to go or be naked in such place, contrary to Florida Statute 800.03.
