The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 03/13/2022 at approximately 0317 hours, TPD Ofc. A. Walker conducted a traffic stop on a black 2014 BMW sedan with Florida tag DWIF18 at the intersection of Tampa St N and Cass St E after it was observed failing to stop at the posted stop bar at the intersection and entered into the crosswalk violating the right of way of a pedestrian. Ofc. A. Walker observed indicators of impairment and requested a DUI investigation be conducted.

I made contact with the defendant and observed her eyes to be bloodshot/glassy, her pupils dilated, her speech was slurred, she was unable to answer basic questions, provided unrequested information when asked questions and had the odor of an alcoholic beverage coming from her breath. She was acting erratic on scene and was observed to have a noticeable sway while standing. She refused to participate in SFSTs and after being read Implied Consent refused to submit to the requested breath testing.

The defendant was positively identified via her Florida drivers license she retrieved from a black handbag. During the inventory search of the vehicle, half of a white rectangle shaped pill with the inscription "9" was located in the handbag. The pill was identified as Alprazolam via drugs.com.
