The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 7/29/2022, the defendant was observed via store security cameras concealing items in her purse. The defendant then passed all points of sale without paying and was stopped by Walmart Security Office Garberg. The defendant initially stopped and spoke with security, but then fled on foot. I was summoned. Garberg gave me a description of the defendant. I jumped in my TPD issued police vehicle and drove west in the parking lot. I observed the defendant running. I stopped my police vehicle in front of the defendant's path of travel, causing her to stop. I exited my vehicle and ordered her to sit on the parking curb. She refused, I ordered her again to sit on the parking curb. She stood in one place. I called for additional units to assist via my handheld radio. I asked the defendant for identification. Without cause, the defendant fled southbound on foot. I drove along side of her and ordered her to stop from my police vehicle. She refused. As she continued running southbound, I observed her drop her cellphone and the black shoes she had in her hands. I continued to drive behind her as she traveled westbound in front of the Banfield Pet Hospital (1510 Hillsborough Av E) . I was able to drive into the driveway and cut off the defendant's path of travel. I exited my patrol vehicle and escorted the defendant to the ground and placed her in handcuffs.

The defendant stole various makeup items, a charger, and cellphone accessories totaling \$86.94. I recovered the make up and cellphone accessories.
 The theft was captured on video surveillance.

The defendant was positively identified on scene as the person who unlawfully took the items, passed all points of sale, and did not pay for the items by Walmart Security witness Garberg.

A criminal history shows the defendant has a prior convicting for Grand Theft out of Polk County on 2/23/21

The defendant was positively identified via her Florida DL .
