The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2018 Alpha Romero SUV (FL Tag #30ABTP) eastbound on Platt St W at a high rate of speed. I paced behind his vehicle for several blocks and observed a speed of 53 MPH. This section of Platt St W is a posted 35 MPH speed zone. While driving, the defendant drifted out of his lane on both sides and crossed over the lane markers. During the traffic stop for the speeding infraction and the suspicious driving patterns, the defendant attempted to stop at the Willow Av S red light, but was slow to react and came to a stop in the middle of the intersection, with all 4 tires past the stop bar. While speaking to the defendant, he was identified via a FL DL and exhibited several clues of impairment to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, fumbling fingers, slow/deliberate movements, tired/lethargic appearance, poor balance, he admitted to drinking 3 alcoholic drinks before driving, and emitted a distinct odor of an alcoholic beverage from his breath. The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking. During the search of his person incident to the arrest, he was found to be in possession of a small, round, white pill, bearing the marking "R 20". Google.com identified this pill as Sildenafil Citrate 20mg (generic for Viagra). This medication is not a scheduled narcotic, but does require a prescription. The defendant was not in possession of a prescription at the time of his arrest. While at CBT, the defendant was read Implied Consent and decided to refuse to provide a breath sample.
