The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a white 2014 Subaru 4-door (CT Tag #AZ65498) northbound on Howard Av S, when he failed to stop behind a black 2022 Mercedes 4-door (FL Tag #TRYST), who was stopped at the Platt St W intersection red light. The defendant rear-ended the victim at a low speed, causing only \$500 in damages and no injuries to either party. The defendant was positively identified as the driver of the white Subaru by the victim.

During the traffic crash investigation, the defendant was identified via a CT DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, droopy eyelids, blank/dazed stare, aggressive attitude, slurred speech, poor coordination, poor balance, tired/lethargic appearance, slow/deliberate movements, he admitted to drinking prior to driving, and he emitted a distinct odor of an alcoholic beverage from his breath.

The defendant was arrested for DUI following a poor performance of SFSTs and was taken to booking. While at CBT, the defendant was read Implied Consent and refused to take a breath test.
