The defendant was ejected out of SOHO Saloon by staff where I came into contact with him where he had a strong odor of alcohol coming from his breath. I was wearing my full police uniform with badge and police markings visible. The defendant knew I was a Police Officer and acknowledged such. Once outside the defendant began yelling and causing a disturbance outside of the establishment. The defendant was getting in the face of another patron out on the sidewalk and was trying to fight the other unknown patron. To deescalate the situation I attempted to move the defendant along which one of his friends was assisting. When I advised the defendant to walk away I motioned for him to leave with my hands/arms at which time the defendant intentionally and purposefully slapped my arms down. This action was against my will and the defendant was immediately grabbed and attempted to be placed into handcuffs. The defendant at this point attempted to flee on foot and resisted officers by tensing and pulling away preventing him from being placed into custody. The defendant was then safely placed into handcuffs on the ground.
