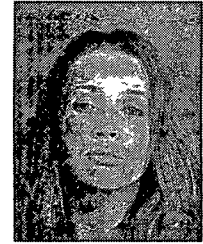

On May 25, 2022 at or about 2204 hours at 2935 N Federal Hwy which is located within the jurisdictional limits of the City of Fort Lauderdale, within Broward County and the State of Florida, the above named defendant did commit the violation of Driving Under the Influence of alcoholic beverage (Florida State Statue 316 193) Elena Gokun did, then and unlawfully drive, or was in actual physical control of a motor vehicle, to-wit Blue Volvo bearing Florida tag JHJZ61 while he was under the influence of an alcoholic beverage to the extent that her normal faculties were impaired or has a breath-alcohol level of 0 08 or more grams of alcohol per 210 liters of breath

On 05/25/2022, I responded to 2935 N Federal Hwy for a D U I Investigation On arrival I met with Officer C Guerra and he informed me that he responded to this location for a minor traffic crash During his investigation he determined that Gokun was the driver of the listed Volvo at the time of the crash and while speaking with her he said she was rambling and appeared confused based on how she was answering his questions

After speaking with Officer Guerra I spoke with about his involvement said he was about to start moving from a red light when Gokun entered his lane and sideswiped his vehicle identified Gokun as the driver of the Blue Volvo at the time of the crash

After speaking with Gokun I met with Gokun while she was leaning against the back of her vehicle I asked Gokun to walk over to my vehicle and she complied While over at my vehicle I explained that the crash investigation was complete and I was called for a

The second exercise performed was a divided attention exercise, which was the walk and turn The walk and turn was performed using an actual line on a flat level dry surface free of debris The directions of the exercise were explained and demonstrated to Gokun at which time I asked Gokun if she understood Gokun responded "yes" I instructed Gokun to begin the exercise The following clues were observed,

- " Can't Keep balance while listening to instructions
- " Starts to soon
- " Stops walking to steady self
- " Steps off the line
- " Uses arms for balance, raising them over six inches
- " Improper turn

Total Clues observed 6 / 8

- " Fails to return arms to the side

I conducted a 20 minute observation and Gokun provided two valid breath samples of 141 and 140 I transported Gokun to the Broward Sheriff's Office Main Jail where she was booked and charged, without incident

The vehicle was towed by West Way Towing to West Way Towing's facility
