The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 7/16/2022, at 0221 hours, I conducted a traffic stop on the defendant for a welfare check at E Fletcher Ave / N 31st St. Upon contact with the defendant I observed signs of impairment, such as glassy/watery/bloodshot eyes, slurred speech, his movements were slow/lethargic, and the distinct odor of an alcoholic beverage emanating from his breath. I requested the defendant perform Standardized Field Sobriety Exercises (SFSEs), to which he agreed. During the exercises, the defendant showed further signs of impairment and was placed under arrest for DUI. The defendant was transported to CBT where he refused to provide lawful samples of his breath after implied consent was read and understood. The defendant was positively identified via an FL DL.
