The defendant was driving a 2014 silver Lexus four door bearing a Florida license plate of LBXC44. She was traveling east on Lockwood Ridge Dr near Heather Oaks Pl and drove off the road, and into the grass and mulch. When Officers arrived, the defendant had the vehicle engine on and in drive. Upon making contact with the defendant she was asleep in the drivers seat and upon being woken up, she attempted to drive away. Officers stopped her before she was able to drive away and the defendant displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, a strong odor of an alcoholic beverage, and unsteady stance and walk. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the implied consent warning.

The defendant was identified by her FL DL.
