On 2/12/2022, at approximately 1946 hours, the defendant was the subject of a reckless driver call for service, while operating a black Toyota, bearing FL tag LGHH27 (VIN: 2T3C1RFV4MC130321) and traveling southbound on Gunn Hwy. The complainant of the call stated the driver of the black Toyota was all over the roadway and unable to maintain a lane. Deputy C. Lowe ABN 256980 observed the black Toyota and conducted a traffic stop at the Gunn Hwy / Vivian Bass Way. Deputy C. Lowe made contact with the defendant and observed signs of impairment, glassy eyes, slurred speech, and the distinct odor of an alcoholic beverage emanating from the defendant's breathe. I responded to the scene, detected the distinct odor of an alcoholic beverage emanating from the defendant's breath, she had glassy eyes, and slurred speech. I requested the defendant to perform Standardized Field Sobriety Exercises (SFSEs) which the defendant agreed to perform. The defendant showed further signs of impairment and was arrested for DUI based. I transported the defendant to Central Breath Testing (CBT). After a proper 20 minute observation period was conducted, the defendant agreed to provide two lawful samples of her breath. Breath technician F. Mason (ABN: 51920) provided the affiant with the results and they are as follows: first BrAC sample .152, second BrAC sample .143. The defendant was identified via FL DL.
