The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was driving a white 2016 Mercedes four door bearing a Florida license plate of LBEY73. She was traveling south on Armenia and made two fast lane changes to get around other vehicles and then sped up and was paced traveling 68 MPH in a posted 40 MPH zone. As I was attempting to catch up to the vehicle it failed to stop for a solid red light at Kennedy Blvd, Cleveland St, and Platt St (ran a total of three red lights). During this time the vehicle was also weaving back and forth. The vehicle then turned east onto Horatio St and came to a stop in traffic at Howard Ave. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, and a strong odor of an alcoholic beverage on her breath. The defendant was also wearing two wrist bands from clubs in Ybor City. The defendant performed SFSEs and multiple clues of impairment were observed. When this affiant placed the first handcuff on the defendant she immediately pulled away and began to fight with violence. The defendant punched this affiant in the back of the head several times causing a small contusion. The defendant also kicked this affiant in the leg. The defendant continued to violently resisted and at no point did she comply with verbal commands. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. In addition, her license is currently suspended for DUI on 09/29/2021, failure to pay traffic fine on 11/08/2021, cancelled on 01/25/2022, and a FR suspension on 09/23/2021.

The defendant was identified by her FL ID card.
