The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a silver Toyota 4D bearing FL tag HJEI61. The vehicle was observed driving northbound on 1275 from the downtown area. The vehicle weaved in its lane and was unable to maintain a single lane. The vehicle varied its speeds, slowing down then randomly speeding up. The vehicle continued accelerating past the speed limit and was paced at 90 mph in a 55 mph zone. Upon contact, the defendant exhibited indicators of impairment to include a dazed appearance and blank stare with glassy eyes. Her speech was slurred at times and I detected the odor of an alcoholic beverage emanating from her breath. She admitted to drinking and was unsteady on her feet. During SFSE's, she asked if we could "wait" since she was "tipsy". She participated SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant provided breath samples of .172/ .155.
