 the above named defendant committed the above offenses charged and the facts showing probable cause to believe same are as follows:

Narrative

came home drunk and began hitting and pushing him and his daughter, (victim) [REDACTED] stated her mother came home from the bar and she believed she was with another man. When [REDACTED] confronted her mother (Emma), her mother slapped her on the right arm multiple times. While I was speaking to [REDACTED] I observed a large red welt on her right arm. There were no injuries observed on the caller, [REDACTED].

I then spoke to Emma who was lying in the bedroom. Emma stated her husband confronted her about cheating and began hitting her. Emma did have fresh scratches on her right shoulder and hands, but both witnesses ([REDACTED]) stated she sustained them when she was holding onto [REDACTED] vehicle when he was trying to drive away from the scene. [REDACTED] stated she did not see her mother or father hitting one another. All parties declined medical treatment.

When Emma was detained, she asked what she was being arrested for and after I told her the charge, she spontaneously uttered, "yeah I did hit my daughter".

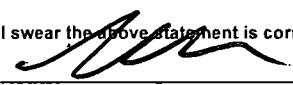
[REDACTED] completed a sworn taped statement and Marsy's form.

Based upon the above facts, probable cause exist to charge the defendant (Emma Moroni) with CRUELTY TOWARD CHILD ABUSE WITHOUT GREAT HARM pursuant to FSS 827.03(1).

[REDACTED] was provided a copy of Article 1, Section 16 of the Florida Constitution. [REDACTED] understands that she enjoys specific victims' rights enumerated in the Florida Constitution. [REDACTED] signed a Victim's Right to Confidentiality Form indicating that she does not wish to invoke her rights at this time.

[REDACTED] does want the defendant released, prior to trial, because it's her mother.

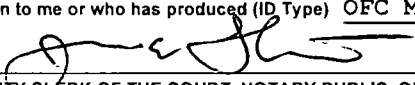
