I responded to 9619 Verona Lakes Blvd in Boynton Beach Florida in reference to a battery complaint. Upon arrival I met with Edward Dolman who told me the following. He has had long standing problems with his neighbor Eric Gunther who lives at 9577 Verona Lakes Blvd. Today, Gunther went into Edwards yard and walked up into his driveway where Dolman was standing just inside his garage. Gunther stopped just outside of the garage while Dolman was just inside his garage. The two were about two feet apart. During the course of the argument, Gunther punched Dolman twice hitting him in the arm area. Dolman said he was holding a stick at the time he was punched. After he was punched twice he said Dolman threw him to the ground. Dolman showed me video footage of the incident which was caught by his in home surveillance system. On the video Gunther could be seen throwing punches at Dolman and throwing him into the ground. Dolman advised me he wanted to press charges for the battery. I went to Gunthers residence and met with him outside of his home. I asked him about the incident and he told me he didnt go into Gunthers yard. He said Gunther and him have a long history and denied going to Dolmans yard today and denied striking him. Dolman smelled of an unknown type of alcoholic beverage and his statement was very inconsistent with what was seen on the video of the incident.
