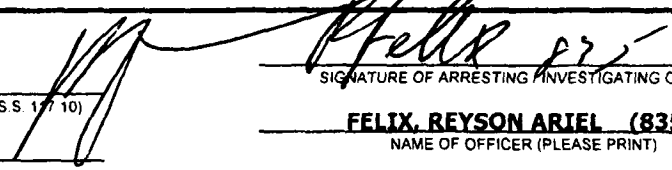

I then contacted Quintero, who stated that on today's date, while coming back from the Zumba class, she observed the victim in the parking lot of the building inside of his vehicle. Quintero then stated that upon getting close to the vehicle, she observed the victim watching porn on his cellphone. Quintero stated that she became upset and started punching the vehicle's window and demanding the victim open the door. Quintero said that once the door was open, she shoved the victim's arms, grabbed the cellphone from his hands, and asked the victim why he was looking at another naked woman. Quintero
