The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02-08-2022, at 2105 hours, the defendant was involved in a two vehicle traffic crash at the intersection of Covington Garden Drive / Covington Stone Avenue, while driving a Chrysler Pacifica bearing FL tag PLZX51 (VIN 2C4RC1GGXLR210462), HCSO case 22-99902, DHSMV #24631832. The total cost of the damage was \$15,000. The witness observed the defendant in the driver seat of the vehicle after the traffic crash. Cpl. Dobson #4809 responded to the scene and observed the defendant displaying indicators of impairment. I observed the defendant displaying indicators of impairment which included bloodshot glassy eyes, slurred speech and I detected the odor of an alcoholic beverage emanating from her breath. Post Miranda, the defendant admitted to driving the Chrysler Pacifica during the traffic crash. The defendant initially agreed to perform field sobriety exercises, but later refused to cooperate. Based on my observations and totality of the circumstances, I arrested the defendant for DUI. The defendant refused to submit to a breath test after being advised of the Implied Consent warning. The defendant was identified via her Florida drivers license.
