The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time at E Bearss Ave / Interstate 275 S within Hillsborough County, the affiant responded to a traffic crash call for service reference an impaired motorist (#22-167638). The affiant learned the driver did not damage any other property beside his own tire. Lieutenant A. Brescia #4698 observed the defendant in the driver seat at the time of the traffic crash and observed indicators of impairment. Upon contact with the defendant, he emitted an odor of an alcoholic beverage from his breath, he had slight slurred speech, and had bloodshot and watery eyes. The defendant refused field sobriety exercises and willingly provided two lawful breath samples. The first BrAC sample was .175 and the second BrAC sample was .179. The defendant was identified via a valid Florida DL.
