The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
The defendant was driving a blue 2017 Chevrolet Silverado (FL Tag #54KHU) northbound on Howard Av N with no headlights illuminated.

During the traffic stop for the traffic infraction, the defendant was identified via a DAVID photo (not in possession of her DL) and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, lethargic appearance, slow/deliberate movements, poor balance, was in possession of an opened container of alcohol (plastic cup with liquor), and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking.

While at CBT, she was read Implied Consent and was asked to take a breath test. She stated that she would refuse to provide a breath sample.
