The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 This affiant has probable cause to believe that the defendant Fadila Dedushaj DOB 12/06/87 violated FSS 784.03.1A1 battery (domestic) upon victim Dennis Freeman DOB 07/28/79 (live in boyfriend).

On 05/29/22 at approximately 10:00 pm at the Hard Rock Hotel/Casino, I responded to the security podium in reference to a possible domestic disturbance. I spoke to the victim who stated that an altercation occurred between him and his girlfriend in a hotel room on property (806 west tower). I observed the victim to have a small laceration on the right side of his abdomen as well as a small amount of blood on his shirt. The victim indicated that it may have been from the altercation and from the defendant's nails. The victim stated that the altercation began due to the defendant wanting to leave the pool party early. The victim was unable to provide further details about the altercation and later stated that nothing physical happened.

I then spoke with the defendant and she also had minor injuries. The defendant stated that the victim grabbed her by the arm and pushed her while entering their hotel room. I observed several bruises on the defendant's inner left bicep. Both statements from the victim and the defendant were inconsistent and I could not determine a primary aggressor. As such, both parties involved were taken in to custody. It should be noted that both the defendant and the victim stated that they lived together and have been a couple for 5 years.
