The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 06/01/22, at approximately 2116 hours, while in the booking process, the defendant Faith Monyhan (W/F, DOB: 04/02/98, HCSO Booking #2021-14751) was being disruptive at the property counter. The victim/Deputy Montufar ABN #254760 responded to the property counter area to secure the defendant in handcuffs and escorted her to Holding Cell #03. As the victim was preparing to remove the handcuffs, the defendant became aggressive by turning towards the victim, picking up her right foot and kicking the victim on her right leg. The victim did not sustain any injuries and did not seek any medical attention. The incident was captured on jail surveillance video. Digital images were taken of the victim. The defendant was identified by detention staff as the inmate responsible for the incident. The defendant was also identified via HCSO Booking information. This incident occurred within Hillsborough County.
