Before me this date personally appeared RESTAINO, MARIANO G (9653) who being first duly sworn deposes and says that on 12 day of April, (year) 2022 at _____ (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

_____ on the ground detaining a male identified as Kardesci Fevzi (02/04/76). Upon contact, I detained Fevzi after security verbally advised he pushed his wife to the ground after being upset due to security cutting him off from the bar. While on the ground, Fevzi continued to resist by tensing and pulling his arms away from my hands while I was attempting to place handcuffs on him. Once back up arrived, I picked up Fevzi to escort him out of the casino. During the transition of escorting Feviz out he tensed his feet and pushed back to stop me from walking him out of the casino.

I then reviewed video footage, which I observed Feviz arguing with Seminole Security _____ just outside of pit 1. During the argument, Feviz was becoming irate and making hand gestures into _____ face. While this argument was occurring Feviz's wife _____, attempted to break up the argument. When _____ attempted to break up the argument Feviz grabbed her by the left bicep then pulled her arm, throwing her to the ground.

Due to Feviz and _____ living in the same dwelling as if a family, and being in a married relationship. Feviz was charged with domestic battery.

Feviz was placed under arrest and transported to BSO Main Jail.
