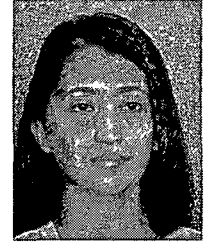

I then spoke to Ara who stated the argument started as verbal, but became physical when she slapped him. Ara informed me that _____ got in her face as she was telling him that she wanted to pack and move out, at which point she used her right hand to open hand slap the left side of _____ face. _____ then pushed him her away from him to get her away from him. There were no marks on _____ face.

I then spoke to _____ again and asked him what transpired. _____ corroborated the story that Ara told me. _____ stated that he got in Ara's face when she began to throw his things out of the room and which point she open hand slapped him on the left side of the face. He pushed her away to not be hit again.

It should be noted that _____ does not wish to cooperate with prosecution of the defendant.

Based on my investigation, Ara was determined to be the primary aggressor and will be charged for Touch or strike/Battery/Domestic violence (784.03-1a1).
