On the above listed date, time, and location, Deputy Skonicki (ABN:257653) conducted a traffic stop on a silver Toyota Tacoma (FL: JMYX05) after observing the vehicle driving on the roadway and was unable to maintain a lane. The vehicle almost struck several vehicles as it continued driving on the roadway. The vehicle was also the subject of a reckless driver call with the complainant giving live updates. Upon contact with the defendant, indicators of impairment were observed which included bloodshot glassy eyes, slurred speech, and the odor of an alcoholic beverage emitting from his breath. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI and later refused to provide lawful breath samples after Implied Consent was read. The defendant was identified via FL DL.
