The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a black 2016 Cadillac 4-door (FL Tag #VML73) eastbound on Platt St W from Howard Av S. While following behind the vehicle, I observed it to drift over the lane marker on the driver's side and straddle it for several blocks. It then drifted back across it's lane and over the lane marker on the passenger's side, straddling it with both tires in the bicycle lane, then back again over the driver's side lane marker again. The defendant continued this suspicious driving pattern from Howard Av S to the Selmon Expressway overpass (). During the traffic stop for the suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred speech, poor coordination, poor balance, slow/deliberate movements, confusion with his paperwork, admitted to spending 6 hours at a bar in Soho and drinking "3 or 4 beers", and emitted a distinct odor of an alcoholic beverage from his breath. The defendant was arrested for DUI following a poor performance on SFSEs, and was transported to booking. While at CBT, the defendant was read Implied Consent and decided to not take a breath test.
