PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:

On June 30th 2022 at approximately .. hrs., I received a call from Officer Drury who advised that she had conducted a traffic stop and believed the driver to be under the influence.

Upon arrival I made contact with Officer Drury who advised that she observed the driver (later identified as Garrett Saunders) of a white Subaru Tribeca displaying FL tag II76VR facing north bound in the second turn lane at the red light of N. Federal Highway and Boynton Beach Blvd. Officer Drury advised that when the north bound straight lane red light turned green Saunders veered over into her lane of travel cutting her off to continue northbound. Officer Drury stated that she then observed Saunders unable to maintain his lane while traveling north on Federal Highway and almost hitting a curb multiple times. Officer Drury then stated that when Saunders approached NE 10th Ave. and Federal Highway he drove almost all the way through the intersection when he then made almost a U-turn and proceeded west on NE 10th Ave. Officer Drury advised that she attempted to stop the above described vehicle at N. Federal Highway and NE 20th Ave. and the vehicle eventually came to a stop at NE 2nd St. and NE 10th Ave. Upon contact with Saunders Officer Drury advised that she was immediately able to observe that he had slurred speech, Blood shot glassy eyes and took a few minutes when asked for the vehicle registration in order to produce it.

I then approached the drivers side of the above mentioned vehicle where I observed the odor of an unknown alcoholic beverage emanating from within and I made contact with Saunders who I observed him to be the sole occupant of the vehicle. Saunders advised that he was driving from Two Georges to his home in Ocean Breeze (East of our location). Saunders stated that he had 2 16 oz. Heineken draft beers and a Single "strong" specialty beer from Hurricane Alley prior to that. While speaking with Saunders I observed him to have slurred speech and he had to search for a lot of his answers.

Based on the above I then asked Saunders to step out of the vehicle and walk to the rear of his vehicle where I could observe him having trouble walking as it was hard for him to keep his balance. Once at there rear of his vehicle I continued to speak with Saunders where he was consistently swaying front to back as well as side to side.

Based on the above information in which I obtained and the evidence in which I observed, I asked Saunders if he was willing to submit to a series of road side sobriety tasks in order to dispel my fears that he is unable to safely drive his vehicle. Saunders agreed to the tasks.

The results of the tasks are as follows;

HORIZONTAL GAZE NYSTAGMUS:

- ☒ Left eye does not follow smoothly
- ☒ Left eye prior to 45 degrees
- ☒ Distinct jerking in left eye at maximum deviation

- ☒ Right eye does not follow smoothly
- ☒ Right eye prior to 45 degrees
- ☒ Distinct jerking in right eye at maximum deviation

☐ Vertical Nystagmus in left eye

☐ Vertical Nystagmus in right eye

WALK AND TURN:

I explained and demonstrated this task to Saunders who stated he understood. While explaining this task to Saunders, he was unable to remain in the instructional position as he lost his balance several times and began walking prior to being told to do so. Upon beginning this task, Saunders would step off the line, miss heel to toe and step off line with every step almost falling over and Officers having to catch him multiple times. Upon reaching his ninth step, Saunders completed an incorrect turn and walked back regularly to the beginning in order to begin again. At this time, I stopped Saunders and explained the instructions to him again. He again walked forward stepped off the line, miss heel to toe and step off line with every step almost falling over and Officers having to catch him multiple times ultimately having to stop due to my concern for his safety as I did not want him to cause injury to himself.

ONE LEG STAND:

I explained and demonstrated this task to Saunders who stated he understood. Saunders was able to balance on his left foot for approximately 3 seconds on his first try then dropped his foot multiple times while attempting to restart. While attempting this task both times Saunders was not able to keep his balance and had to be caught by officers. Ultimately the task was stopped due to my fear that Saunders would cause injury to himself if continued. During the duration of this task Saunders did not count out loud.

FINGER TO NOSE:

I explained and demonstrated this task to Saunders who stated he understood. While demonstrating this task to Saunders he attempted to start and interrupt multiple times prior to being told to do so. Upon his first attempt at this task Saunders lifted his left foot off of the ground on the first instruction then advised that he didn't understand what to do. I once more explained and demonstrated this task to Saunders where he once again stated that he understood and once he started missed finger to nose each time, kept his eyes open, did not tilt his head back for the duration of the task and did not immediately bring his finger back down to his side.

ROMBERG/ALPHABET:

I explained and demonstrated this task to Saunders who stated he understood. While demonstrating this task to Saunders he attempted to start and interrupt multiple times prior to being told to do so. Upon his first attempt at this task Saunders lifted his left foot off of the ground on the first instruction then advised that he didn't understand what to do. I once more explained and demonstrated this task to Saunders where he once again stated that he understood and once he started missed finger to nose each time, kept his eyes open, did not tilt his head back for the duration of the task and did not immediately bring his finger back down to his side.

Based on the above, Saunders was placed under arrest (handcuffed D/L and checked for tightness) at 0106 hrs. Once at PBCJ, I began a required 20 min. observation period at 0125 hours. After completing this, I requested Saunders submit to a lawful sample of his breath for the purpose of determining its alcohol content. At this time, Saunders advised that he did not know I then read Saunders Implied consent to which he stated that he did not know again which was taken as a refusal. I then read Saunders his Miranda Rights to which he stated that he understood and refused to answer questions invoking his right to council.

Based on the above I find probable cause to charge Garrett C. Saunders with DUI pursuant to FSS # 316.193(1)(A). Saunders was then processed and turned over to the quality care and control of the PBCJ.

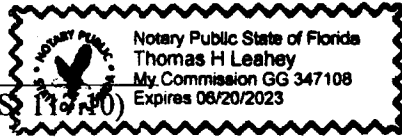

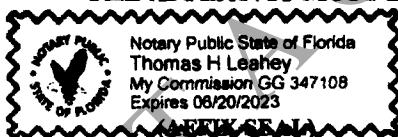
