The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a white 2014 Maserati bearing a Florida license plate of JLRL76. She was traveling north on Dale Mabry Hwy at W San Pedro St and was rear ended. The traffic crash involved three vehicles and the driver of one of the vehicles complained of neck pain, but refused to be transport to the hospital. The victim will seek treatment at a later time. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, dilated pupils, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (two sangria), and an admission to consuming Adderall. The defendant performed HGN but refused other SFSEs. Multiple clues of impairment were observed during HGN. When your affiant went to placed the defendant into handcuffs she tried walking away, and tensed and pulled her arms in front of her body in an attempt to prevent officers from handcuffing her. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
