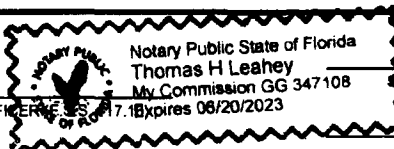
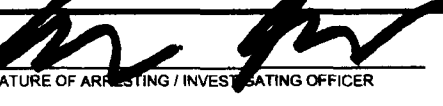

PROBABLE CAUSE STATEMENT	On 08/03/2022 at approximately 0115 hours, this Officer was north bound on Interstate 95 approaching Northlake Blvd, PBG, FL, when a vehicle was observed driving without lights activated after dusk. Body worn camera and in car video were used.						
	The vehicle, a Lexus utility vehicle (CSLL02/FL) was in the second lane from the outside shoulder without any visible lights to the rear. The vehicle was also observed drifting into the lane to the right as well as drifting within the lane. Fearing for the safety of both the occupants and other motorists, this Officer initiated a traffic stop on the vehicle, just north of Northlake Blvd. The vehicle entered the outside through lane and took approximately one mile to finally come to a stop on the right shoulder, just north of mile-marker 79 on northbound Interstate 95, PBG, FL. This Officer made contact with the driver, identified via Florida Driver License photo, Gladys Reyes (OF) while she was still in actual physical control of the vehicle.						
	Reyes had slow slurred speech, glassy watery eyes and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. Reyes appeared completely unaware she did not have lights activated as they are "auto". Reyes said she was coming from "a work event" and was bringing passenger to a hotel. When asked how much she had to drink, she replied "like two glasses of wine".						
	Based on this Officer's observations, Reyes was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which she complied. Reyes said she did not have any medical conditions which would affect the exercises performed.						
ADMINISTRATIVE	The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight with an illuminated red tip. This Officer observed a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Reyes also had the onset of Nystagmus prior to 45 degrees in both eyes and

Vertical Gaze Nystagmus in both eyes, twice. Lastly, Reyes had a lack of convergence in both eyes twice. The second exercise conducted, was the Walk and Turn. The line used, was a strip of yellow tape placed upon the pavement by this Officer. Reyes had difficulty entering and remaining in the starting position. Reyes raised her arms from her sides repeatedly. During the first set of steps, Reyes missed heel-to-toe eight times and raised her arms more than six inches from her sides. After the turnaround, Reyes stepped off the line just prior to taking her first step. Reyes then missed heel-to-toe on all steps and again raised her arms more than six inches from her sides. Reyes paused after the ninth step and took a tenth step, counting same aloud as well. The third exercise conducted, was the One-Leg Stand. During the exercise, Reyes raised her right foot. Reyes swayed and raised her hands more than six inches from her sides. Reyes also did not look down as instructed nor count as instructed. The fourth exercise conducted, was the Finger to Nose. During the exercise, Reyes used the pad of her finger to touch the tip of her nose, rather than the tip of her finger, through all six commands, with the exception of two anomalies. During the first and second commands of Right, respectively, Reyes touched under the tip of her nose then corrected herself and touched the tip of her nose, still using the pad of her finger. The fifth exercise conducted, was the Rhomberg Alphabet. Reyes recited the alphabet correctly, while swaying back and forth. Based on this Officer's observations and the totality of the circumstances, Reyes was placed under arrest at 0133 hours. After being placed under arrest, Reyes became increasingly upset and began a loop of repeating herself. Reyes made multiple comments about two or two and half glasses of wine and not wanting to go out tonight. Reyes also kept repeating she was driving a friend to a hotel and blamed this Officer for her transgression. At PBSO BAT, this Officer requested Reyes provide a breath sample for the purpose of determining its alcohol content, to which she agreed to do so. At 0231 hours, she blew .134 and at 0234 hours she blew .128. Based on the results of the investigation, this Officer has probable cause to prove Gladys Reyes operated a motor vehicle, in the state of Florida, while under the influence to the extent her normal faculties were impaired, with an unlawful breath alcohol content, in violation of FSS 316.193(1)(C).
