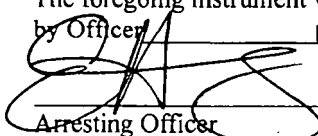

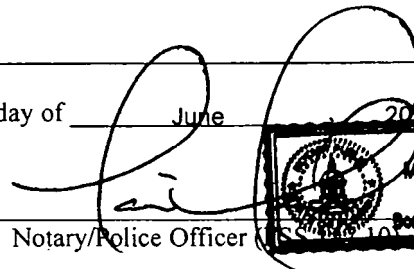
On 6/6/2022, I responded to the parking lot at 1200 W Linton Blvd in reference to a motor vehicle crash. The responding crash investigator requested officer assistance with a DUI investigation. Investigator Roth advised that she observed the subject, Glenn Cohen, had slurred speech and difficulty balancing. I made contact with Cohen and advised him of the DUI investigation.

Cohen had difficulty balancing and droopy eyelids. His speech was slurred and he appeared to be confused. I asked Cohen if he suffered from any medical conditions or injuries and he stated o. I asked Cohen if he took any medications or used any drugs and he stated no. When asked about the crash, Cohen stated that his "phone went into gear" causing him to hit the vehicle ahead of him. Cohen tried to show how his phone changed the gear selecting dial, but was unable to duplicate it.

As Cohen exited the vehicle, he rocked back on his heels and nearly lost his balance. Cohen again lost his balance as he walked away from the drivers door. I requested that Cohen perform the Standardized Field Sobriety Tasks to which he initially agreed before refusing. I advised Cohen that the tasks are designed to dispell the suspicion of impairment, that I would have to make a decision based on the information already obtained and that his refusal could be used against him in court. Cohen stated that he understood and again refused.

Cohen was handcuffed and taken into custody without incident. I then transported Cohen to the Breath Alcohol Testing facility at the Palm Beach County Jail. Upon my arrival at 1332 hours I completed the required 20-minute observation. I then requested Cohen provide a sample of his breath for the purpose of determining the alcohol content. Cohen complied and provided the requested breath samples. The results are: 0.000 and 0.000. I requested a urine sample to detect the presence of chemical or controlled substances and Cohen agreed. Implied consent was read on camera in case Cohen later refused. Cohen successfully provided a urine sample that was submitted to evidence for testing.

Post-miranda, Cohen admitted to smoking an unknown amount of marijuana at approximately 8am.

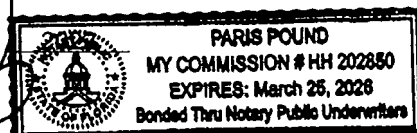
