I responded to the [REDACTED] 33426 in reference to a suspicious incident.

Upon arrival I met with the VICTIM who advised the following which was captured via body worn camera: VICTIM stated that on Monday, June 2022 at approximately 1600 hours, her ex-boyfriend and father of her child W/M Gregory Goodrich (DOB 8/1/70) arrived at her residence with their [REDACTED]. She advised that at the time, she was not present at the residence but that her family friend W/M David Ciambrose (DOB 6/22/61) was housesitting for her. VICTIM stated that [REDACTED] knocked on the door of the residence and [REDACTED] answered the door. [REDACTED] was there in order to pick up some belongings and [REDACTED] let [REDACTED] into the residence while Goodrich stood behind [REDACTED].

According to VICTIM, [REDACTED] told Goodrich to wait outside and began walking upstairs with [REDACTED]. VICTIM stated that [REDACTED] turned around while walking up the stairs and saw Goodrich walking up the stairs behind him. VICTIM stated that she did not give permission for Goodrich to enter her residence and that part of their current custody agreement is that he is not supposed to be at her residence at all. [REDACTED] stopped Goodrich from going any further up the stairs. [REDACTED] gathered some belongings and then left the residence with Goodrich and the belongings, to include a shirt, backpack and a trophy. VICTIM stated that because she never gave Goodrich permission to enter her residence, and because [REDACTED] had told Goodrich to wait outside and Goodrich entered the residence without permission and left the residence with items from inside, she wished to pursue criminal charges for burglary.

I then spoke with [REDACTED] who provided a sworn statement captured on my body worn camera: [REDACTED] stated that there was a knock at the front door of the residence and he saw [REDACTED] standing outside. When he opened the door he observed [REDACTED] with Goodrich standing behind him. He stated he allowed [REDACTED] to enter the residence but told Goodrich to wait outside. [REDACTED] advised that he began walking up the stairs and when he turned around, Goodrich was following up the stairs behind him. He stated he did not give Goodrich permission to enter the residence. He further advised he would be willing to testify in court to this account.

I then made contact with [REDACTED] while VICTIM stood by. [REDACTED] advised that he arrived at the residence with Goodrich in order to pick up some belongings to include a shirt, a backpack and a trophy, as well as an Apple Airtag that belonged to Goodrich. He stated he felt weird because he knew VICTIM was not home at the time and it did not feel right being there with Goodrich while VICTIM was not present at the residence. He advised that he entered the residence and saw Goodrich inside the residence at some point and Goodrich asked for the Apple airtag. [REDACTED] corroborated the fact that Goodrich did in fact enter the residence and leave with items.

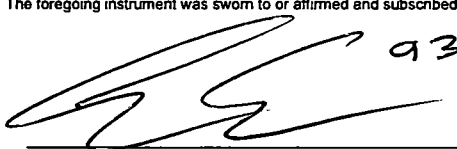
