The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 03/27/2022 at approximately 2048, affiant conducted a boat stop on a black 2015 23' Monterey boat bearing FL8917RA / Hin: RGFMK296H415 at the Davis Island boat ramp located at 864 Severn Av Tampa, Hillsborough County, FL 33606 for a navigation light violation and the purpose of a safety inspection. Upon stopping the boat, affiant made contact with the operator/defendant. During personal contact with the defendant, affiant observed him to have blood shot watery eyes, detected a strong odor of an alcoholic beverage coming from his breath and noticed he spoke with a slurred speech. Based on this, affiant requested the defendant perform seated sobriety task to determine if he was operating a boat while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant refused to perform the SFSTs. Based on the totality of the circumstances and in the interest of public safety, affiant arrested the defendant for boating under the influence. The defendant was transported to Central Breath Testing located at the Orient Road Jail. Upon arrival, the defendant was read Florida Implied Consent (2147 hrs). The defendant advised he understood and refused to provide a breath sample. The defendant was booked into the ORJ without incident. The defendant verbally identified himself and produced a Florida drivers license.
